BOOKING RULES

Winter rates and periods shall be determined by the Board each year and printed on the Booking Application Form.

1. Winter booking applications from Members, who must be financial at the time of booking, shall be accepted from 1 March each year (or another date as determined by the Board). The Booking Officer shall strictly allocate beds in order of receipt of booking applications once bookings have opened. Applications received prior to the opening of bookings will be deemed to have been received at 12 am on the opening date. Unless otherwise advised by the Board bookings from Member's friends will be accepted from 1 April (or another date as determined by the Board).
2. The number of persons accommodated per night at the Smiggins Lodge is limited to 20. In the event that the Booking Officer receives, at the opening of bookings or at the same time once the bookings have opened, more than 20 applications (excluding children under 5, by the terms of our lease) for a particular period, the Board will conduct a ballot.
3. Bookings are made on a per night basis with a minimum of two nights per booking. Arrival time is after 2 pm, rooms are to be vacated by 11 am on day of departure. All meals are supplied.
4. Single night bookings are permitted (incl. weekends) if booked within 7 days of day requested, subject to availability.
5. Bookings (other than 1 night) cannot start or finish on a Saturday.
6. All applications shall be made to the Booking Officer on the approved form. The FULL AMOUNT must be paid on all bookings up to and including \$200. For bookings over \$200, a deposit of 50% must be sent with the booking form.
7. The balance of any booking must be paid 1 month prior to 1st booked day.
8. Should cancellations occur, a cancellation fee of 10% of total accommodation value will be charged if cancellation is received 4 weeks prior to arrival date. Between 4 weeks and 2 weeks prior to arrival date, a cancellation fee of 50% of total accommodation value will be charged. If the booking is cancelled less than 2 weeks prior to arrival date, the total value of the accommodation will be forfeited unless the beds can be filled. If the beds can be filled an administration fee of only 10% will apply.
9. Minimum age for accommodation at Smiggins Lodge is four (4) years.
10. Children will not be granted accommodation unless accompanied by a parent or guardian.
11. Phone inquiries may be made to the Booking Officer as per the booking form regarding available dates, however a phone booking must be confirmed by the receipt of the completed booking form and deposit within seven (7) days or the phone booking will be cancelled.
12. A receipt for any money received, with advice as to whether the application has been successful will be emailed/mailed to the applicant.
13. Residents at the Lodge wishing to extend their stay, should a vacancy occur, must contact the Booking Officer. If successful, they are to inform Lodge managers and pay them the applicable amount.
14. Lodge residents shall at all times occupy the room allocated by the Booking Officer unless alternate arrangements can be made through the Lodge Managers.
